Inviting the best possible providers into our community and supporting them is essential to ensuring access to high quality care. In 2022, we added 6 providers in cardiology, oncology, otolaryngology, podiatry and more.

By continually investing in our facilities, we're helping to ensure that we continue to meet our community's healthcare needs. Last year, we spent \$2.3 million in capital improvements, including investments in a new DaVinci robotic surgery system, seven anesthesia machines, 15 new vital signs monitors, ultrasound equipment, a nuclear medicine thyroid uptake system, a sleepworks system and HVAC improvements.
